### A WORD FROM YOUR PRESIDENT

We have hired a management company to handle the day-to-day operations of Capital City Golf Club Estates, which includes compliance of the CC&R's. Pictures we be taken once a month of properties out of compliance and a letter will be sent out to the registered home owner. The first letter will list the problem and the CC&R's that it falls under. The home owner should contact us and let us know what they plan to do.

If the home owner feels we are wrong, they can challenge our decision. It is explained in the CC&R's and also on the fee system, recently sent to each homeowner May 1, 2015.


Just because we've been lax enforcing the rules in the past doesn't make the ongoing violations acceptable. It's possible you don't remember agreeing to the CC&R's when you bought your home or it's possible that you may have come into your home, by default. For example, if your parents owned the house. Perhaps you ended up with it or maybe you are renting it out. You are still required to follow the CC&R's. If your house is part of Capitol City Golf Club Estates, then the CC&R's need to be followed. We didn't have any system of fines in place, but we do now.

These fines are posted on our web site along with the CC&R's. Also every home owner has received a copy.

The CC&R's require that your house and property must be kept in good order and appearance. If you have a boat, motor home, trailer, extra car or truck it needs to be parked on a driveway or parking area that is black top, cement, or crushed rock. Not the grass or front lawn. *Blue tarps are not a fashion statement*. Motor homes/RV's may be parked on your property but not lived in.

Lawns need to be mowed, flower beds need to be weeded, shrubs trimmed and off the street. Fences need to be maintained in good condition. Garbage cans and recycle bins or cans should have a place to sit other than in front of the garage doors. For instance, in a fenced-in area on the side of the house.

The moment I realized I need to be part of the solution against criminal activity in our community was the rape that occurred in Hoskins Field. While I realize my children will need to learn about these terrible happenings of the world, it does not need to take place where you, I, or they live. I can do something about it, and I want to help protect my community, so I have asked to join the neighborhood watch program.

Both my husband and I are originally from Upstate New York, which is also where I received my Associates degree in Paralegal studies. I worked as a legal secretary for six years at a Fortune 500 company, often performing paralegal duties. I have also interned

at a public defenders office to gain first-hand knowledge of the court system. ### **GOT MOSS? PRESIDENT TOM SUGGESTS:**

**Moss is a problem** we have around here, especially if you have large trees or other shaded areas around the house. It will even destroy concrete if you don't keep after it.

There are several ways to remove moss and also keep it under control. This goes for roofs as well as concrete, walls, sidewalks or patios.

If the moss has a good build up and it is dry, you can use the back side of a shop broom and run it back and forth to remove a large portion of the moss. Then use the broom the right way and be aggressive going back and forth to remove more of the moss. If you have a pressure washer,now would be a good time to get the rest of the moss spores.

This works on the roof as well as the concrete or bricks. If you don't have a pressure washer you can wash the affected areas then spread baking soda lightly over it. You can buy 13.5 lbs. of baking soda from Costco real cheap. The best way to spread it is to open the top of the bag and spread it like you were feeding chickens. It takes about three bags to do a 1500 sq. ft. home.

If you don't want to pressure wash or sweep with a broom—or the moss isn't that bad, just spread the baking soda before a rain and let nature clean off the moss. It'll take some time but it works without much labor.


